## **IMPORTANT SCHEDULING INFORMATION**

1. MAGIC will call you within 2 business days of your referral. You will need your insurance card for this scheduling call, so keep it handy. If you need to reach MAGIC, call (302) 225-2380 ext 351 (office visits or procedures with sedation). Call (302) 995-2656 for information about Virtual Colonoscopy.
2. Your driver must stay with you or be immediately available when you have an EGD or Colonoscopy with sedation. Believe it or not, some drivers who leave never return!
3. The bowel preparation for colonoscopy can be purchased at our Newark (Apex Bldg. Suite 203) and St. Francis locations or can be mailed to you. Please review the Video Prep Instructions at [www.midatlanticgi.com](http://www.midatlanticgi.com). The Virtual Colonoscopy prep can be purchased at our Newark (Apex Bldg. Suite 202) location.
4. If you cancel your EGD or Colonoscopy procedure within 3 business days, you will be charged a \$100 fee. Your GI doctor, nurses, and anesthesia team have reserved your appointment time for you and arrangements for another patient to move into your slot cannot be made without significant advanced notice.

Note that procedures with sedation are not done in the Apex Bldg. in Newark but are done at the Metro Bldg. in Newark, as well as at St. Francis and Christiana Hospitals, at Glasgow Ambulatory Surgery Center and at the Wilmington Hospital.
